Overview

Process maps are graphical models of workflows that link to programs, browses, and other process maps. You can view, edit, and create process maps in the QAD .NET User Interface using the Process Viewer and Process Editor. The QAD .NET User Interface stores process maps in XML files. This technical reference lists the process maps for QAD Enterprise Applications – Enterprise Edition.

This chapter provides some guidelines for using, creating, and editing process maps in QAD applications.

Note For detailed information on editing process maps, refer to *User Guide: QAD 2008 User Interfaces*.

Process maps illustrate the principal business and operational processes within a QAD application, and consequently, provide graphical navigation. A process is a structured set of activities designed to accomplish a specific objective.

Process Map Views

There are two separate views for process maps in QAD applications: the Vertical Industry View and the Supply Chain View. Both views lead to the same detailed maps.

When you create a new process map, you must link it to the appropriate hierarchy in both views to make it accessible to users.

Vertical Industry View

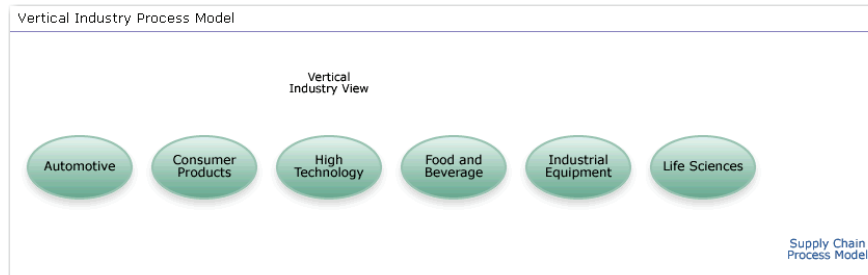


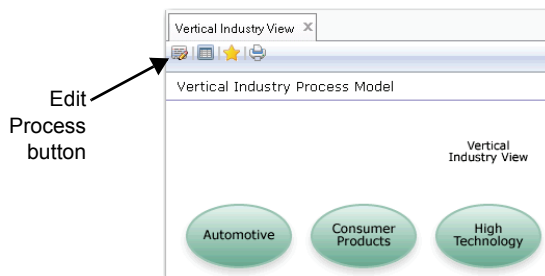

Editing Process Maps

You can edit the process maps published by QAD using the Process Map Editor. You can access the Process Map Editor using the Edit Process button in the toolbar.

Edit Process Button

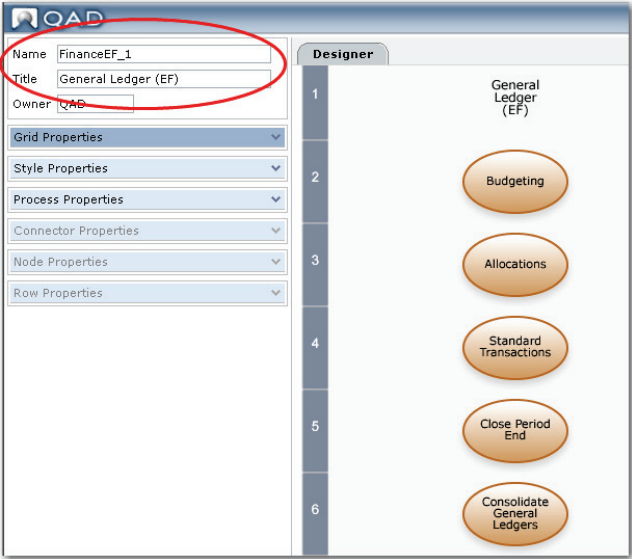


Note The process map files you draw in the Process Map Editor are generated as .xml files

Map Filenames

The process maps published by QAD are identified by two pieces of information: an alphanumeric name, which is also the process map filename, and a title, which is displayed on the process map breadcrumb.

Note The title will not appear on the actual process map. You must enter the title as a Text node for it to appear on the process map.

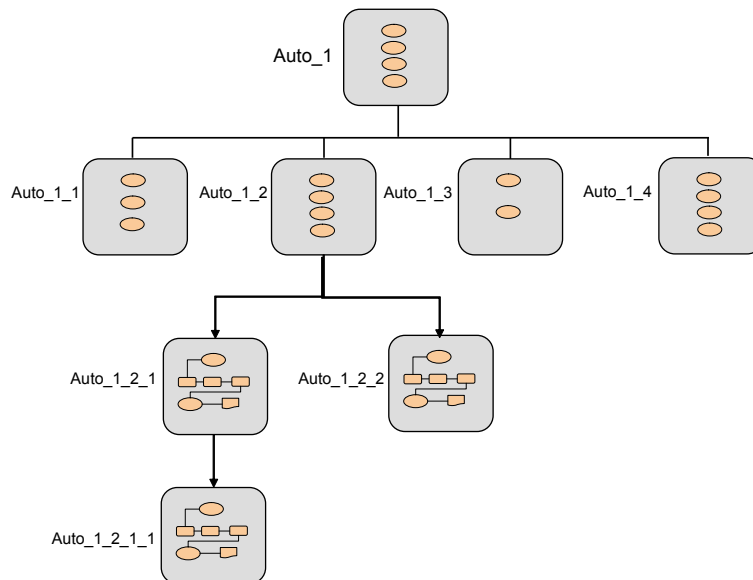

All QAD process maps begin with a code that identifies the functional area to which the map belongs, followed by a number that indicates the map's place within the map hierarchy for that area. For example, the first map in the Automotive area is named Auto_1.

If Auto_1 opens four sub-maps, they would be named Auto_1_1, Auto_1_2, Auto_1_3, and Auto_1_4. If two maps open from Auto_1_2, they are named Auto_1_2_1 and Auto_1_2_2. If two maps open from Auto_1_2_1, they are named Auto_1_2_1_1 and Auto_1_2_1_2.

Map Naming Hierarchy

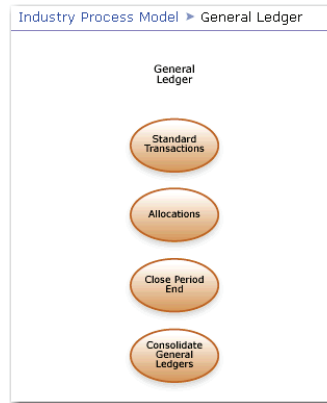


Map Titles

Level 1

When you click on a high-level node, you open a high-level vertical map for that functional area.

Level 1 Title



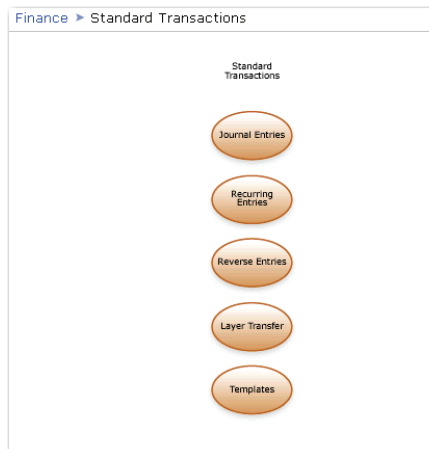
The titles of level 1 maps are located above the maps, and are printed in black text.

Level 2

When you click on a node in the level 1 map, you open a subsequent process map vertical for that area, or a more detailed process flow.

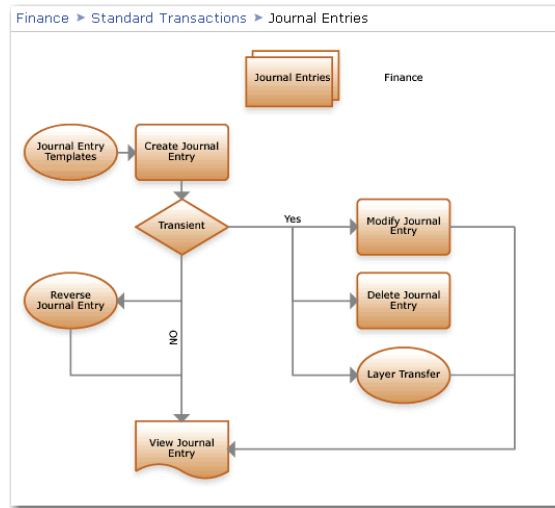
If Level 2 of the map hierarchy consists of another vertical menu, the title of the menu is located above the map in black text, like a level 1 title.

If Level 2 of the map hierarchy opens a detailed process map, the title is represented in a collection node.

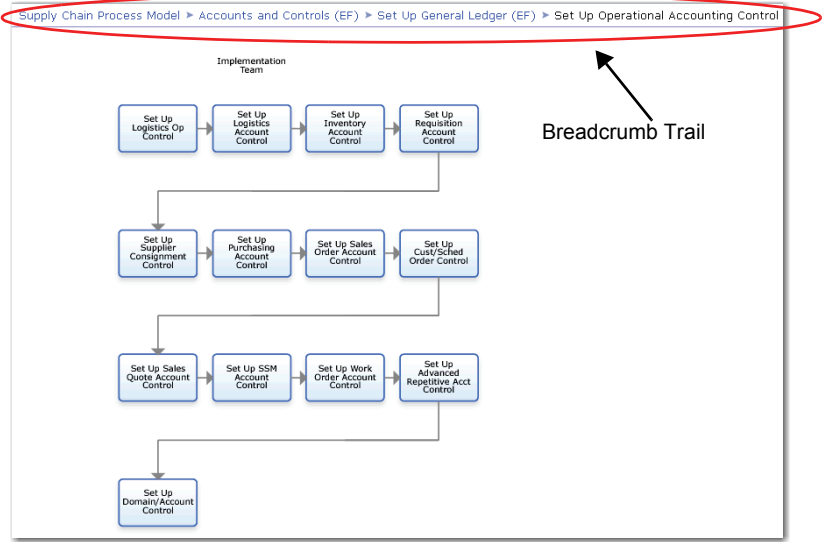

Lowest Level

At the lowest level of a process map where the map does not open any subsequent maps, the title is not placed above the map. Instead, the title is indicated by a breadcrumb trail.

Nodes

When creating process maps for QAD applications, you can use seven types of nodes.

- The Menu Item symbols indicates a link to a program on the menu.
- The Other Process Map symbol connects activities on one process map to another process map.
- The Menu Item Collection symbol links to collections.
- The Manual Step symbol indicates tasks performed outside of the QAD application, for example, external planning tasks.
- The Decision symbol directs the flow of a map when it can branch in two directions.
- The Document symbol represents reports or files, such as Word documents or Excel spreadsheets, that are relevant to a task.
- The Manual Input symbol indicates inputs to the process from external systems or outputs from the process to external systems, for example, Electronic Document Interchange (EDI).

In QAD applications, nodes also indicate a user's permissions with regard to functionality. If the user does not have access to a linked program, the node grays out.

Linking Nodes to Maps and UI Objects

Use the Link field in the Process Editor to specify what the current node will open, for example, another map, a URL, or a window in the UI.

To link to another map, use the process property {QAD_PV}, for example, *{QAD_PV}mapname*.

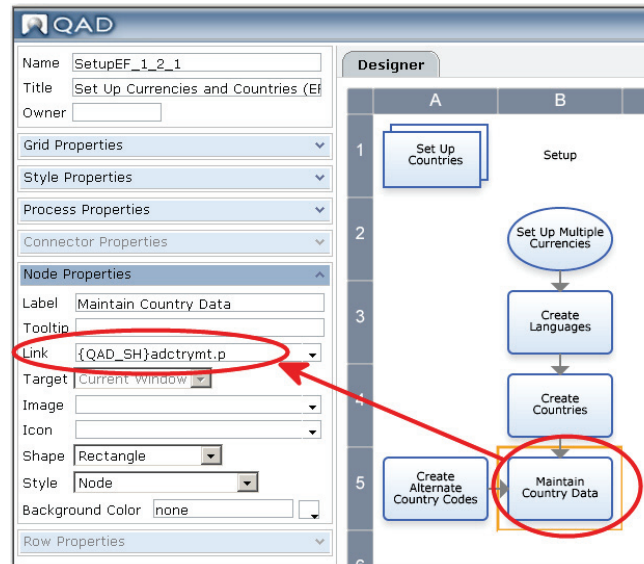
To link to a QAD window, use the process property {QAD_SH}, for example, *{QAD_SH}componentprogramname* for .Net UI component windows, reports, and processes, and *{QAD_SH}progress programname* for Progress windows.

To link to a URL, enter the URL.

The following are usage examples for the Link field in the Process Editor:

- {QAD_PV}SetupEF_2_4
This node will open a process map named SetupEF_2_4.
- {QAD_SH}BLanguage.Create
This node will open the Language Create .NET UI component window.
- {QAD_SH}adctrymt.p
This node will open the Country Data Maintenance window.

Note You can also use *{QAD_SH}menunumber* to link to and open .NET UI component windows. However, because menu numbers can change from release to release, it is recommended to use the component program name when linking.

The Link field is case sensitive.

Layout

In QAD applications, process map nodes are arranged in a grid. Use the grid to lay out process nodes in a way that is easy to follow.

The following are some guidelines on layout:

- Organize nodes in such a way that the length of the connectors is minimized.
- Move the nodes as close to each other as possible.
- Make the space between boxes as uniform as possible. It is better to have a simpler layout with fewer tasks than a more complicated one showing all steps.

The default grid size is 6 x 6. You may not need to use all the rows or columns, but the finished map must appear within a 6 x 6 grid. Reducing the size of the grid may increase the size of the nodes and create consistency problems when the process maps are printed.

The maximum grid size is 7 columns x 9 rows. Exceeding this limit will cause the size of each node to decrease and become too small to read when incorporated in printed documentation

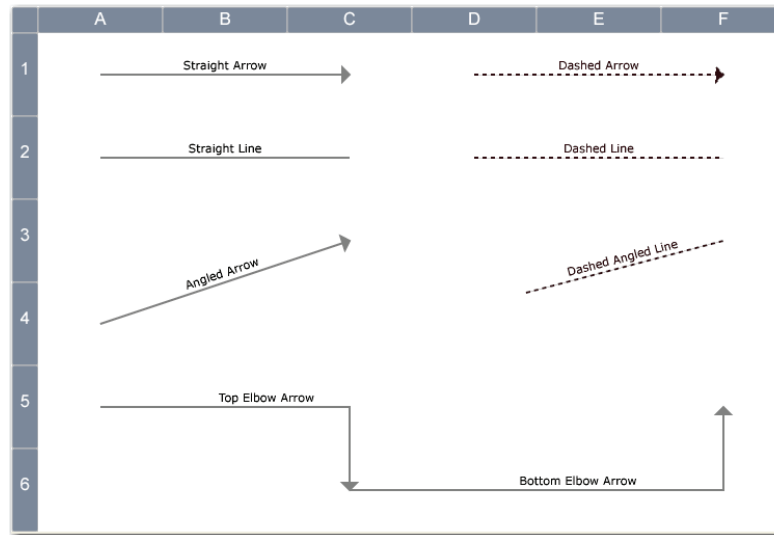
If the size of a map exceeds the 7 x 9 row limit:

- Remove extraneous rows or columns.
- Simplify the map by removing tasks.
- Move some tasks to a separate process.

Arrows and Connectors

Figure 1.13 shows the arrow and connector types available in the Process Editor.

Arrows

Flow arrows indicate the order in which activities are performed, and depict the process flow. The usual direction of the flow of a procedure or system is from left to right or top to bottom.

If your design includes two or more arrows leading from a single process node, this can be represented using a decision node.

Connectors


It is recommended not to cross connectors because they make the process map less readable. Split the process map into two pages, if necessary. Interchange the direction of Y and N on decision boxes to avoid crossing connectors or to reduce the length of the connectors.

In QAD process maps, dotted lines are used to denote optional steps.

Creating or Modifying Process Maps

The following are guides for creating or modifying process maps:

- 1** Decide the boundaries of the process, such as what step initiates and ends the process.
- 2** Name the process. A good process name clearly indicates the result or end state of the process.
- 3** Create a paper design of the process map.
In the earliest design stages, it can help to write steps down on cards or paper to allow easy rearrangement.
- 4** Prototype the map by sequencing the steps and decision points.
Consider the next task in the process, whether a decision point is required, and whether the map reflects the actual process.
- 5** Review the prototype with colleagues who are familiar with the process. Rectify any issues discovered during review.
- 6** Review the process map design with colleagues unfamiliar with the process to determine if the map flow is clear. Rectify any issues discovered during review.

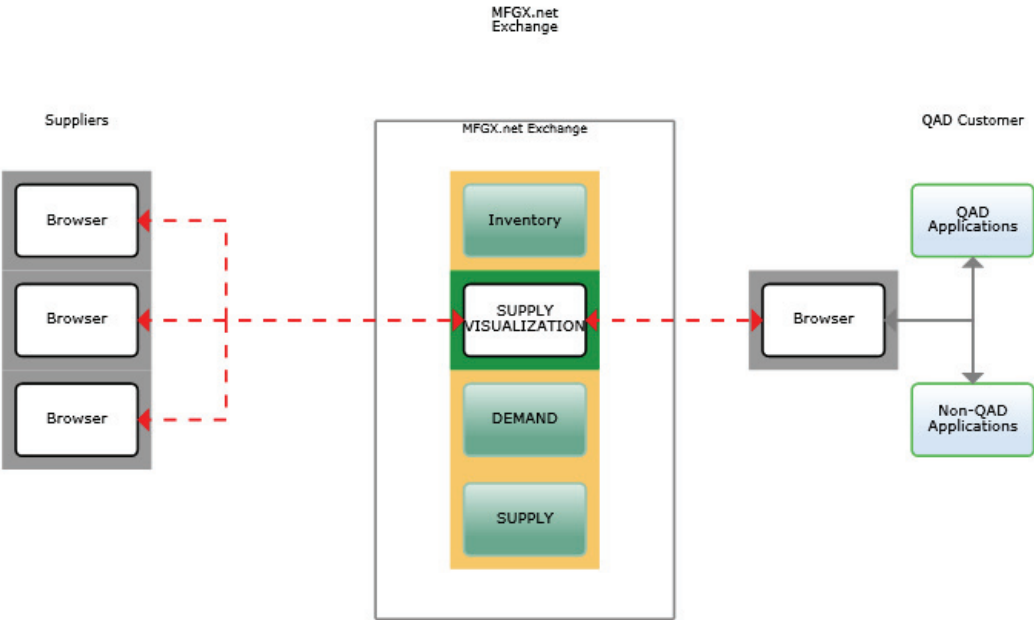

Supply Chain Process Model



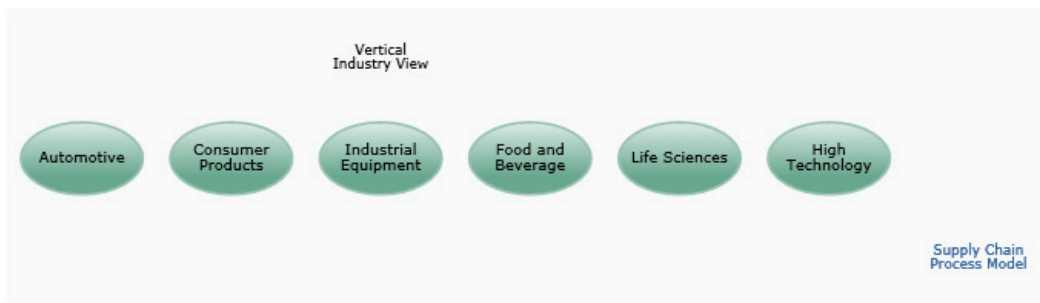

Set Up Currencies and Countries (EF)

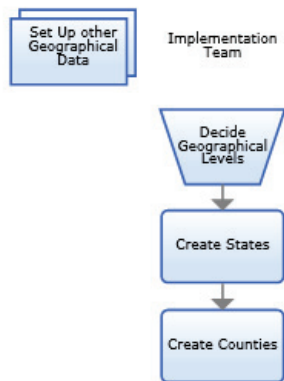

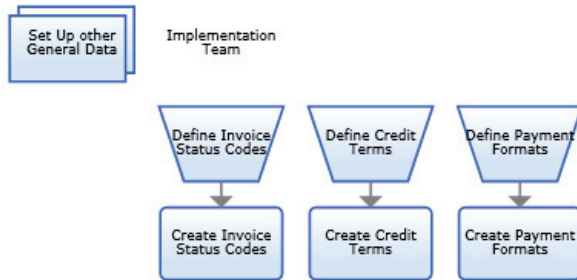

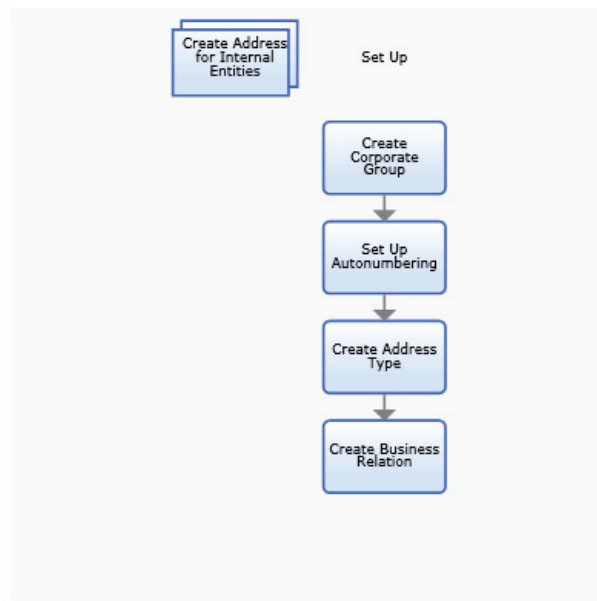

Create Address for Internal Entities (EF)

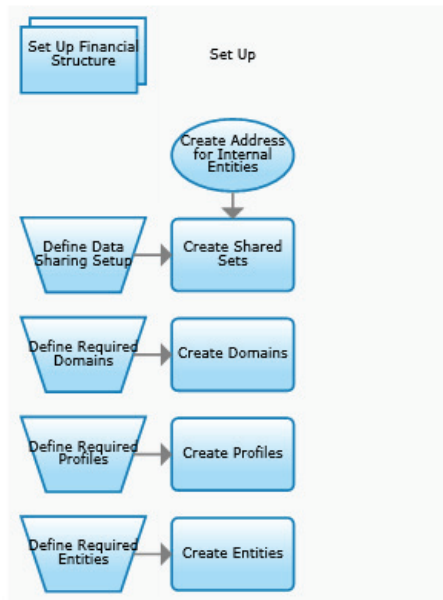

Set Up Corporate Structure (EF)

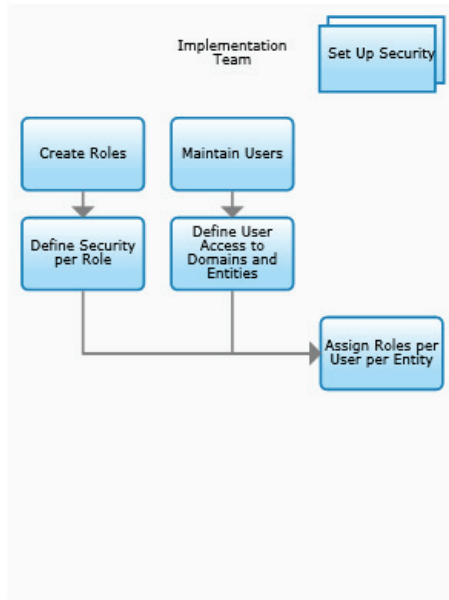

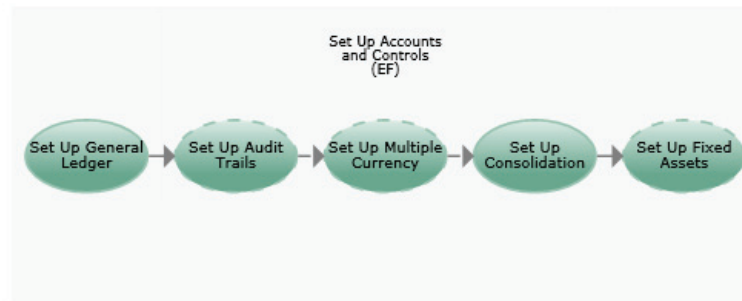

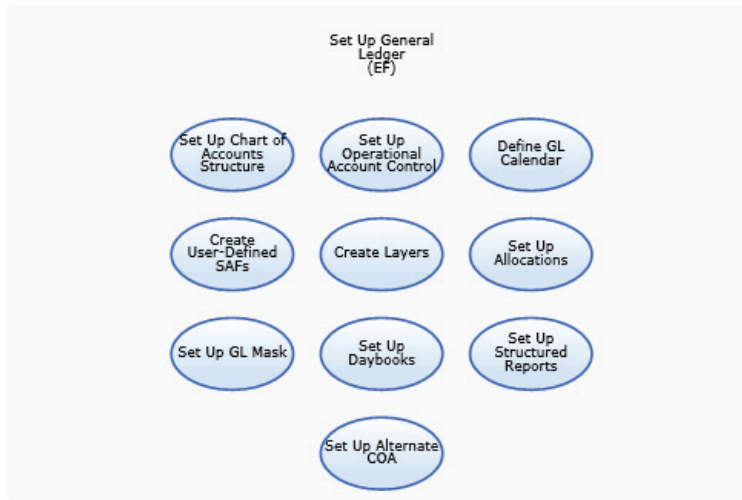
Set Up Accounts and Controls (EF)

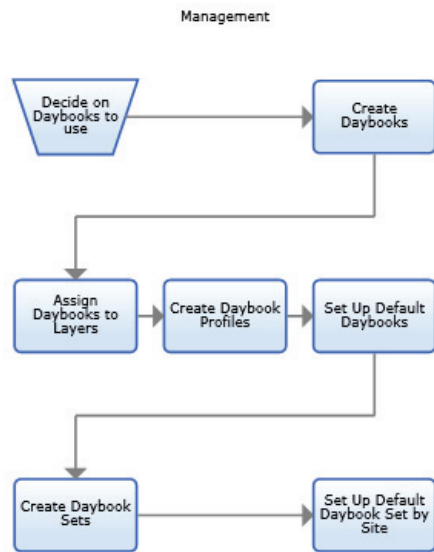

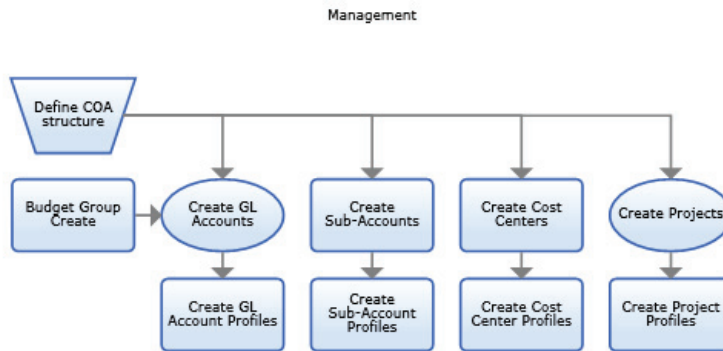

Set Up Charts of Account Structure

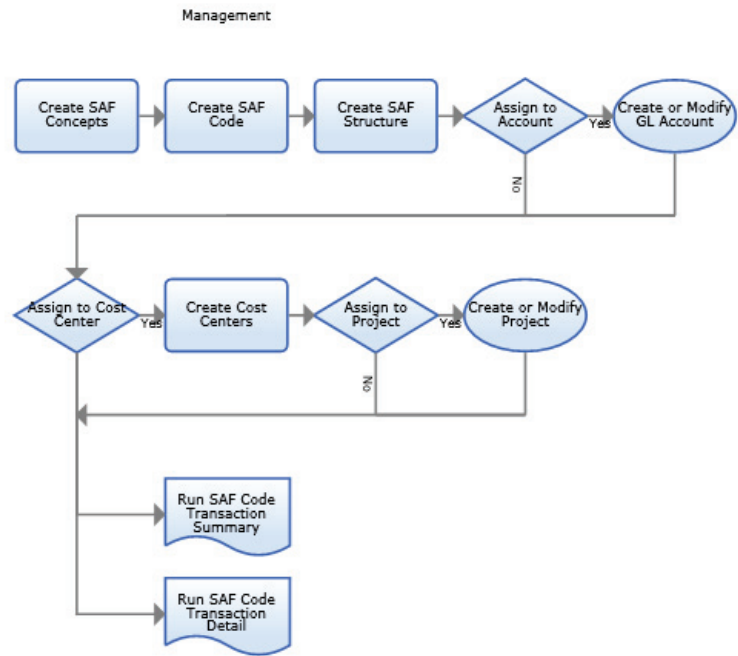

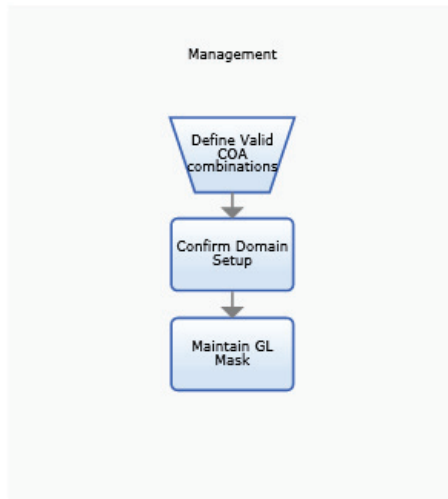

Set Up GL Mask

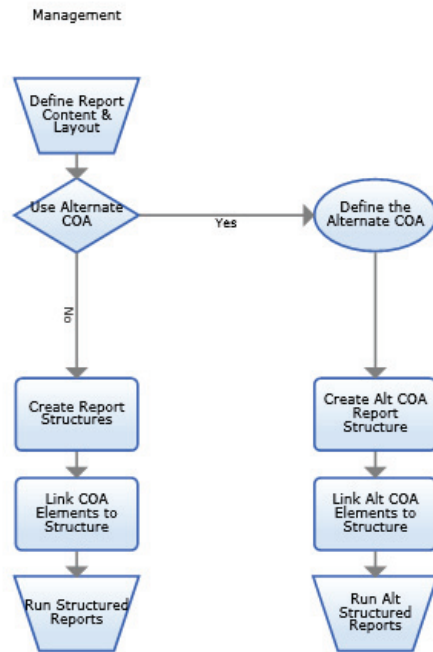

Set Up Operational Accounting Controls

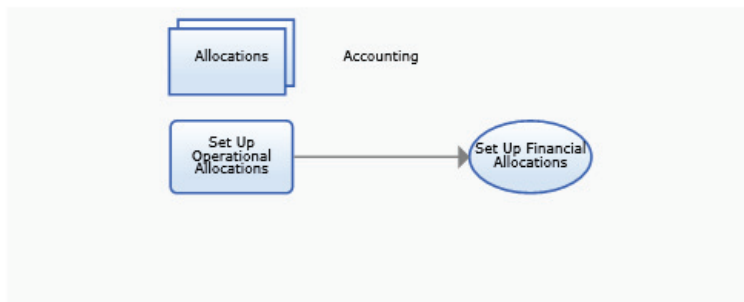

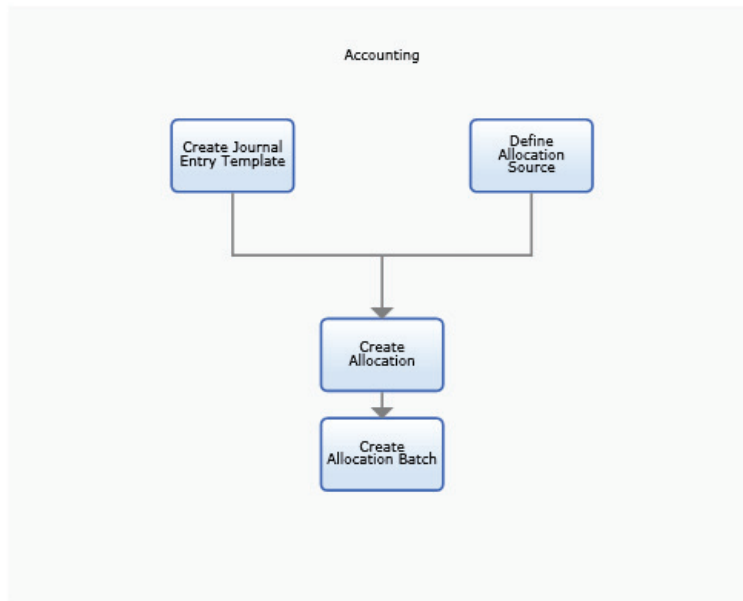

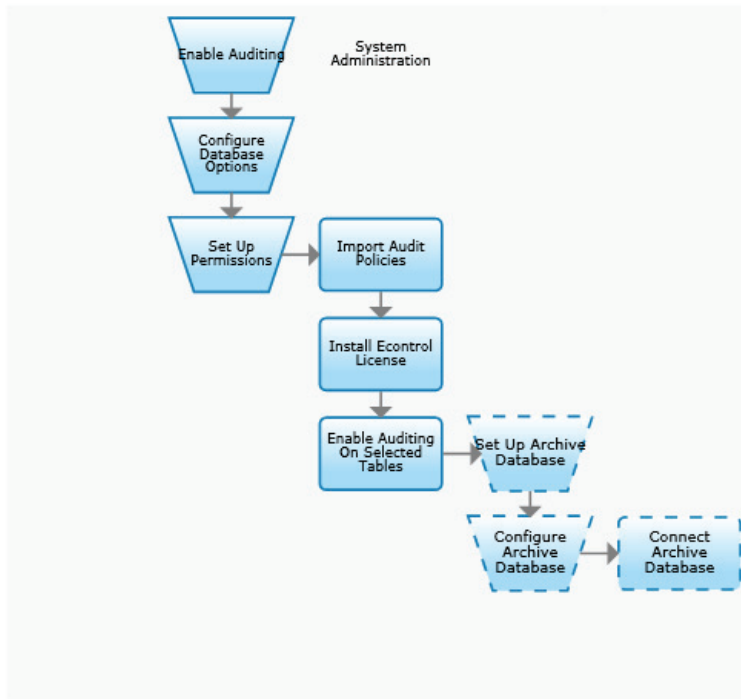

Set Up Audit Trails

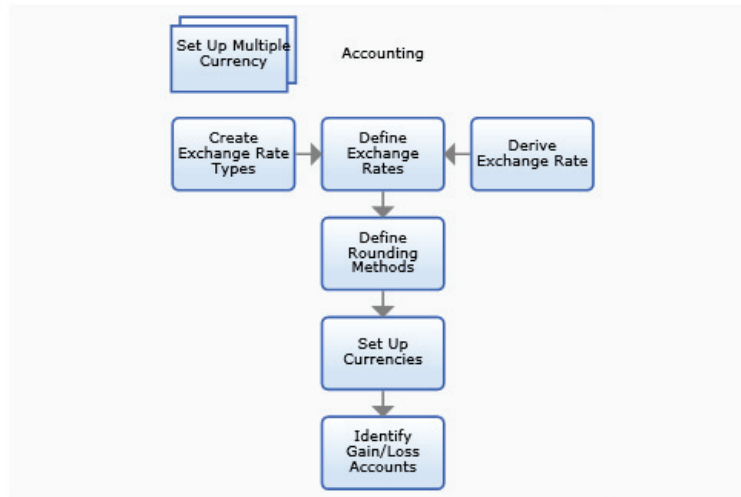

Set Up Multiple Currency

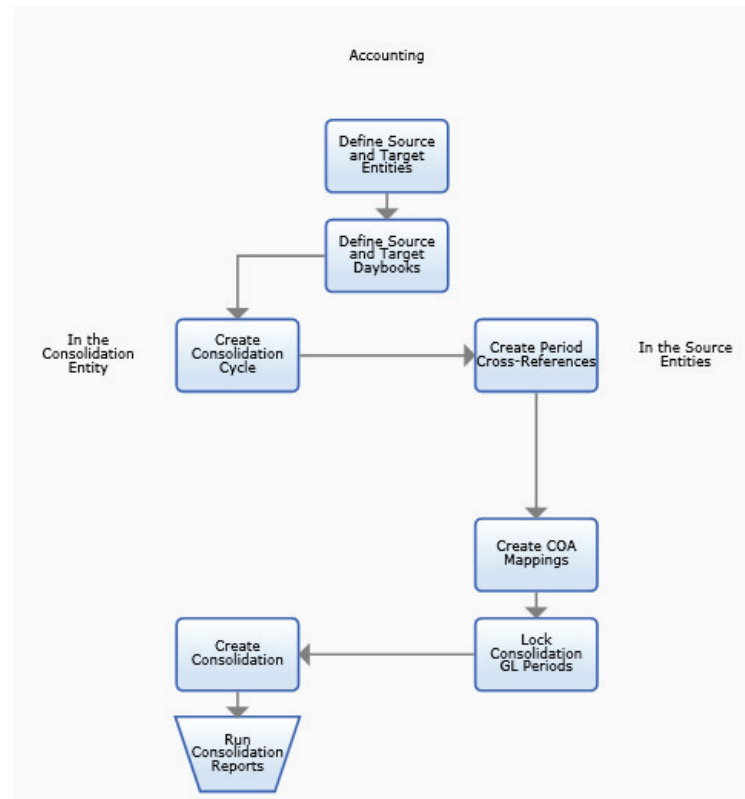

Layout Warehouse

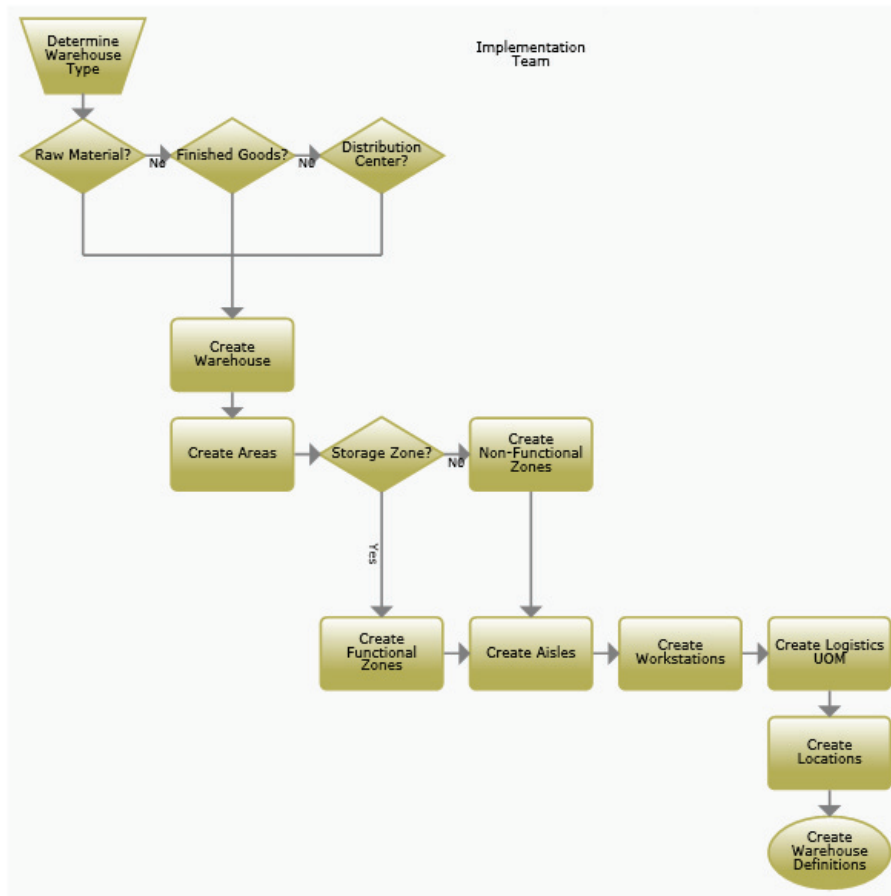

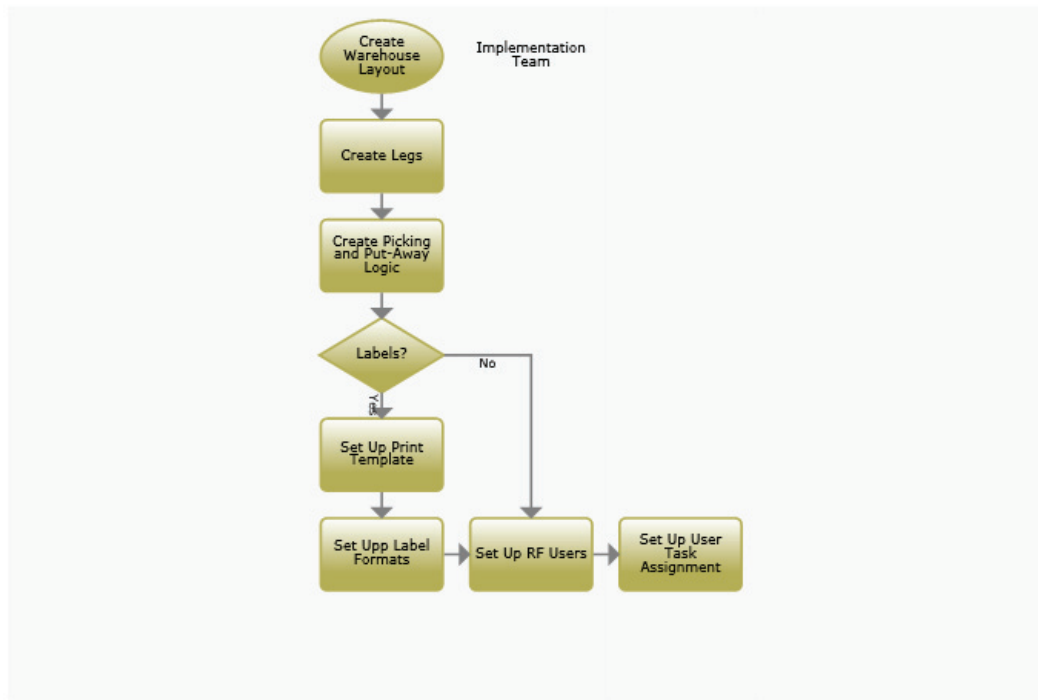

Create Warehouse Definitions

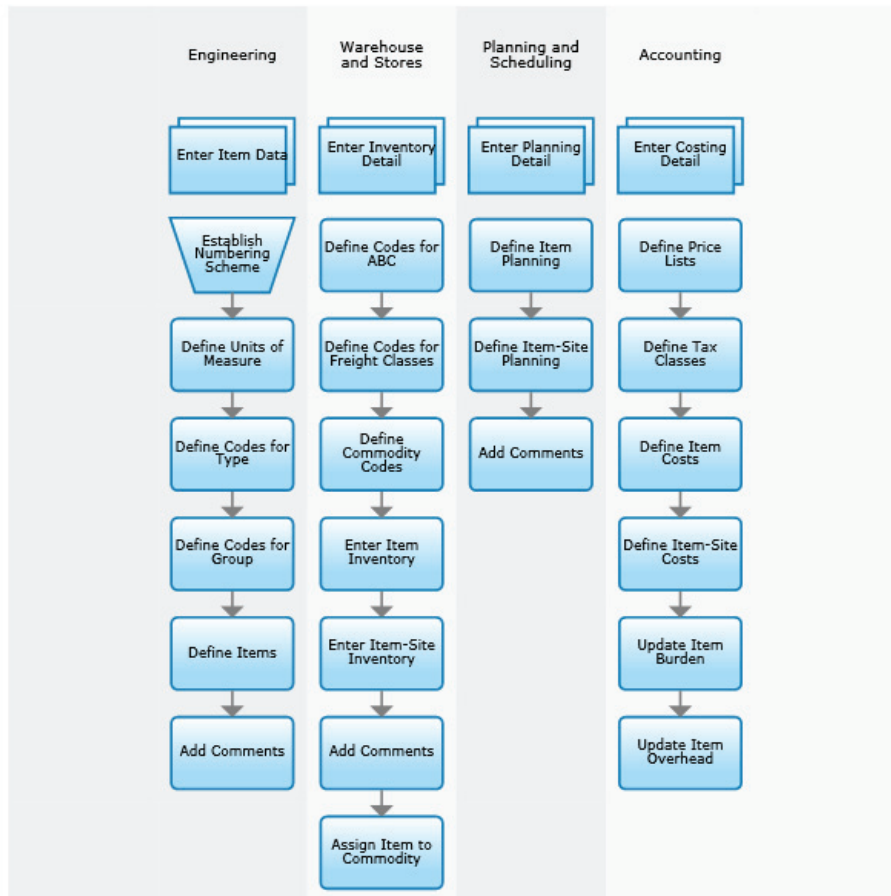

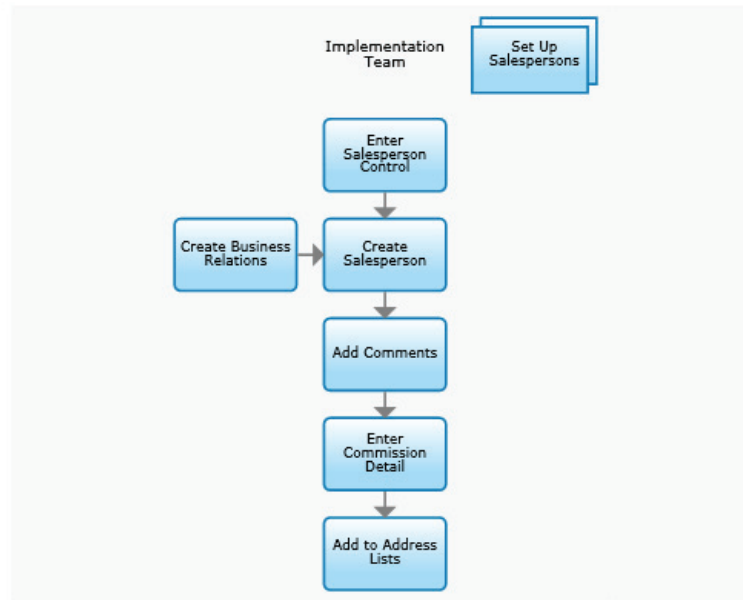
